

AREA 12 - DELAWARE GENERAL SERVICE ASSEMBLY DELEGATE'S REPORT AREA ASSEMBLY - DECEMBER 7, 2024

- 1. PLBB sold out its first printing of 70,000 copies within the first two weeks.
 - a. The discrepancy in applying the advisory action was discussed at the NERD monthly meeting on November 17th and the GSC sharing session with the board of trustees on November 22nd.
 - b. Scott H., Board chair, announced that the language adjustments to the PLBB required by the conference not followed by the board were a regrettable and unintentional error.
 - c. The second printing is underway and it will have the Conference directed changes.
 - i. <u>Chapter 5 HOW IT WORKS</u>, page 64: remove the sentence "It seems to control and punish people who are addicted to it" from the last paragraph.
 - ii. New addition GLOSSARY, page 9: remove the definition of "Addiction" from the Glossary section.
 - iii. <u>THE DOCTOR'S OPINION, page 11:</u> change Hospital for Drug and Alcohol Addictions to Hospital for alcoholism and drug addiction.
 - iv. THE DOCTOR'S OPINION, page 14: revise the sentence "I help people recover from their alcohol and drug addictions" to "I help people recover from their alcoholism and drug addiction."
 - v. <u>Chapter 13 A VISION FOR YOU, page 139:</u> revise "hospital for the treatment of alcohol and drug addiction" to "hospital for the treatment of alcoholism."
 - d. This is a message from KY women's jail "Update: Update: U

referencing the PLBB. Light bulbs and miracles go off everywhere - you can see it happen.

- 2. Literature sale for the holidays (sent email out to DCM's);
 - a. 4 book historical pack (first printing of the first edition facsimile, AA Comes of Age, Dr. Bob and the Oldtimers, and Pass It On) for \$30 (\$8 savings, no limit).
 - b. First printing of First Edition facsimile \$3.
 - c. 15% off all orders over \$200.
- 3. 2024-2026 Edition of the AA Service Manual available online on our website under "What's New" and on AA.org. On aa.org it tells you can order the book online but it's not available yet. It links you to the bookstore and when you scroll to the AASM, it will be the red current edition. As soon as we get notice of the hardcopy availability, we will send out a notice to the DCMs and post it online.
- 4. NERAASA registration. Feb 21-23, 2025. Online. \$35. Sent out the email invitation to DCM's, officers, committee chairs and past delegates.
- 5. Next NERD online meeting is scheduled for December 15th. At the last one, on November 17th, we discussed:
 - a. Why preliminary PAI list is not being shared with the delegates (and, therefore, the Fellowship); that the reason given by the Board as having received complaints that it is confusing the Fellowship is inadequate; and that it is necessary for all of us to see what the Fellowship is thinking about. We were advised by the NERT that it is a topic to bring up at the upcoming online Conference sharing session. I will discuss this in more detail a bit later.
 - b. Discussion on the matter pertaining to Bob W.'s (GSO manager) November Gratitude letter asking for more contributions in order to increase the prudent reserve. I raised the issue as to whether people or groups can earmark contribution in order to ensure the money goes

directly to the prudent reserve since most of it is held in a separate bank account (CD) and all contributions go to the general fund. NERT noted that finances don't work that way; that we have income and expenses and what' left over is prudent reserve. NERT referred me to Bob W. to continue the discussion. (Note: 2024 Conference report shows that as of end of 2023, the \$13.2M reserve fund has more than \$10.4M in a CD account and almost \$2.8M in cash and cash equivalents which is marked separately from the general fund.)

- c. We were reminded about the deadline for the vacant Trustee-At-Large vacancy timeline. We'll be selecting our nominee in new business today.
- 6. Notes and highlights of the GSC online sharing session of November 22, 2024.
 - a. The topic was "Integrity of the General Service Conference." 3 presenters shared their experience and thoughts: A non-trustee director in AAWS; a GSO staff member assigned to the Literature trustee committee; and the Panel 74 delegate from San Diego. The presenters reflected about the definition of integrity, our 12 Traditions, 12 Concepts and Warrantees, our personal responsibility, group conscience, and delivering information without editorializing.
 - b. Best definition of integrity was this: the "alignment of our actions with our deeply held values and virtues." My takeaway is: are we doing that at Conference, at GSO and at the GSB in relation to Concept I where the ultimate responsibility and authority is with the Fellowship (Groups).
 - c. Two conference issues were raised: one being the alleged leakage of information about the PLBB during the conference (news to me) given that all delegates are made aware of the rules of the conference at the outset: that no information should be shared with the outside during conference. The other was that a few delegates shared they were being lobbied for votes.
 - d. Other matters raised by delegates:

- i. Number of delegates complained about the preliminary list of PAI's not being shared and that Board is not complying with an Advisory Action. Board members responded they were doing so but their decision to do that in February is in compliance with the advisory action and that the delay is due to workload and translation. A GSO staff member shared that there were only 12 GSO staff members. (Board changed both precedent and expectations of the timing of the PAI's; GSO recently created and staffed a translation department and has been able to provide the list in prior years.) The upshot was that delegates were talking about the lack of trust in the board.
- ii. One delegate stated that there is a deviation from our principles relating to AA's responsibility to Concept I.
- iii. Several delegates shared their feelings/experiences about the deficiency in the conference process: that there is insufficient time or information to make truly informed decisions on important issues (PLBB; floor motions; founders writings, e.g.)
- iv. The quality of translation of documents is worsening.
- v. Communication, communication, communication...
- e. Scot H., board chair, said communication is very important and the board, during one of its week-ends spent 4 hours discussing ways to improve communications. Then he reported on the PLBB which I I discussed above in Item 1.
- f. My input at this sharing session went like this:
 - i. The Board didn't comply with an Advisory Action in that it established a precedent as to how and when it would provide the list, then changed it without the permission of the Conference. The trustees seem to have an unfettered authority in deciding which PAI's get discussed at Conference. That kind of action is more suitable to governance than the intent of the upside-down triangle.
 - ii. In this regard, while it was brought to my attention by a trustee that the conference charter gives trustees the right to



determine which PAI's go to Conference, it is my considered opinion that such a "right" is a misinterpretation and misapplication of Item 10 of the Conference Charter. The relevant section speaks to the reserved right of the Board to determine which of its actions or decisions may require the approval of the conference. The word ITS is a possessive pronoun relating to financial and policy integrity of AAWS and GV, which is the relevant matter and the heading of that subsection. It is not relevant to the indiscriminate application of matters originating from the Fellowship.

7. Normally, by this time, after the Board has had their Fourth Quarter meeting (last weekend in October), we get a list of <u>ALL</u> PAI's submitted for consideration. This year there were 143 (memo indicating the trustee committee distribution is attached). The Board decided not to share them until the final decision has been made which comes after the January Board meeting. The Board says that early distribution of all agenda items cause confusion over what items are forwarded to the conference. So, it's not until the middle of February when they release the final agenda items and provide a list of the ones that will not be forwarded to the conference or that were otherwise disposed of. Traditionally, we've been provided a preliminary list. This showed us what other areas and people in AA are thinking.

We, the delegates did receive a preliminary conference agenda in November which shows the PAI that were approved so far by the respective trustees committees. This list still has to be approved by the board in January 2025. This document was shared by some delegates with their Areas but other delegates have chosen not to do so. I'm attaching it for your edification. PLEASE DO NOT SHARE OUTSIDE OF AA OR ON ANY SOCIAL MEDIA PLATFORMS.

Please take note of the following items:

- a. PAI's on codifying the BB and 12x12 in the conference charter were accepted as well as the process to change any language by the use of a supermajority see PAI's 81, 15 & 109 (pp. 7-8); PAI 96 (p. 10).
- b. PAI's regarding updating the book living sober. See pp. 11-12. Lots to think about since it will be a significant topic at the 75th GSC.

Other PAI's I sent up, some discussed at the September assembly were not forwarded to the conference:

- a. PAI 111 GSB create a process to permit the submission of editorial and textual changes to the PLBB. No action taken noting that a sub-committee has been charged to develop a comparable process. (This is an example of an item not forwarded to the conference for a decision but the trustees literature committee taking action within their purview on the suggestion.)
- b. PAI 104 the Board never approve the reprint of the PLBB simplified language 12 Steps to any outside entity. AAWS took no action saying that it is the responsibility of the licensing department though my "comments were noted."
- c. PAI 102 regarding data formulation of information for important issues such as the founders writings, e.g. The General Service Conference trustees committee took no action as they didn't see a widely expressed need. (This one boggles the mind last year the literature trustees committee saw fit to get feedback from the entire fellowship through the delegates yet they don't want to establish any metrics by which to capture this information for important discussions at the conference. Seriously?!!?)
- d. PAI 110 regarding contingency plans to have translators and tech people available for after hours on Friday to conclude the conference. The Trustees on the General Service committee took no action stating that the process currently exists and is within the

- control of the co-chairs who manage the time in order to conduct the business of the week. (A tone deaf response, in my view.)
- e. Floor Action #7 regarding the consolidation of all PAI's from previous conferences be grouped together and forwarded to the 75th conference and the Fellowship for a wider discussion similar to what was done with the founders writings. No response has yet been provided and does not appear in the preliminary conference agenda.
- 8. International Convention Registration online is still open. New news (sent out to DCM's Wednesday was about the flexibilities offered by the University of BC. 1 bedroom (C\$71/night), 2 bedroom w/ semi-private bath (C\$177/night, and 4 bedroom apartment dorms (C\$328/night) (Canadian currency).

The IC committee is seeking recommendations from the delegates for speakers at the international convention. I have not submitted any yet and I'm looking to the GSR's and DCM's for recommendations. The IC committee is seeking 800 names and they only received a little more than 100. Attached to my report is the topics for speakers and the information needed. Please send me your recommendations as soon as possible along with their required information and a short paragraph why you think they would be best to carry the message of AA at a venue like the international convention. Of course, the first requirement is that they be attending the convention and paying their own way. GSO will not be picking up their travel expenses.

9. Now to finances – you may have seen Bob W.'s (GSO GM) November gratitude letter asking again for "regular and incremental" donations because our prudent reserve is below the desired level of 9-12 months. He stated that it's at 6.41 months as of September 30th and about \$4.8M is needed to bring it up to the desired level. I referenced the letter earlier in Item 5, above. See also my November report to the Area Committee which is posted on our website in the delegate's page.



While the conference has previously suggested that the prudent reserve should be around 9-12 months, it specifically made no requirement. This is sometimes referred to as "corporate poverty" which is a spiritual principle. In accordance with Warranty Two of Concept XII, Bill W. says that book sales constantly renew the reserve fund especially when contributions don't pay for AA's services.

AA's 3rd Quarter financial report (as of 9/30/24 - unaudited) showed an 11% increase in contributions over last year and 7% over budget. Net literature sales were 4% over last year but 4% under budget so far. The report also indicated a projected \$1.2M operating surplus as of 9/30/24 which is greater than both last year and this year's budget. The report also noted a rise in prudent reserve from 6.41 months to 7.2 months. See below chart:

It should be noted that profits from the sale of the 70,000 PLBB's was not

included in the 2024 budget or the reforecast budget although the PLBB first printing cost of \$60K was. The sale of the PLBB did not occur until Q4 and I'm not sure where the printing costs of the second printing will be charged. I would think it would be part of Q4 2024 since the board said that the second printing is under way. The upshot here is that we should see even a greater increase in literature profit due to the PLBB and the push for holiday gift sales I mentioned in Item 2, above.

With respect to the Grapevine, the Q3 financial report shows that though the net profit from GV subscription is almost 10% higher than last year due to the higher margins from digital content, it is on target with the 2024 budget. Its operating expenses are on target with a higher than budgeted shortfall of \$626K. LaVina is also budgeted for a shortfall of \$436K which is approximating the budget. GV/LV is on a 5 year plan to break even by the end of 2026 but in the meanwhile it is drawing an annual draw from the prudent reserve of more than \$0.5M.



Greetings from GSO. I hope all is going well for you. We received 143 PAIs total by the September 30, 2024 deadline (see chart below).



After consideration, 11 new agenda items (covering 25 submitted PAIs forwarded to the GSC.

The following key dates were included in the "Save the Date Memo" shared on August 2 attached.

- Preliminary GSC Agenda: November 11-16 (Including PAIs forwarded to Conference)
- Final GSC Agenda: February 17-25 (Including PAIs forwarded to Conference)
- Conference Committee Background Distributed February 17-25
- PAIs Not Forwarded to GSC: February 24-28

Last year, sharing a list of all submitted PAIs led to misunderstandings about which items were actually on the Conference agenda. During the trustees' GSC committee meeting on January 12, solutions were discussed to clarify confusion surrounding the PAIs. Therefore, this year, a complete list of submitted PAIs will not be distributed.

Instead, this week a preliminary GSC agenda which includes PAIs forwarded to Conference will be distributed. And in February, a list of PAIs not forwarded to Conference will be shared.

During the Delegates' only meeting in March 2024, I provided a verbal update on these developments and wanted to send this reminder.
