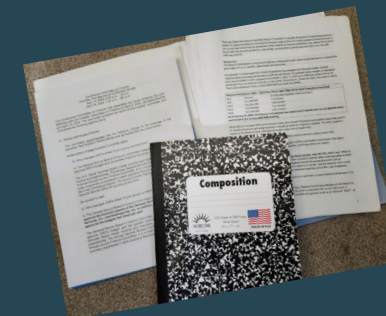
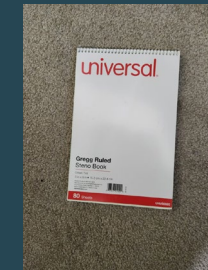
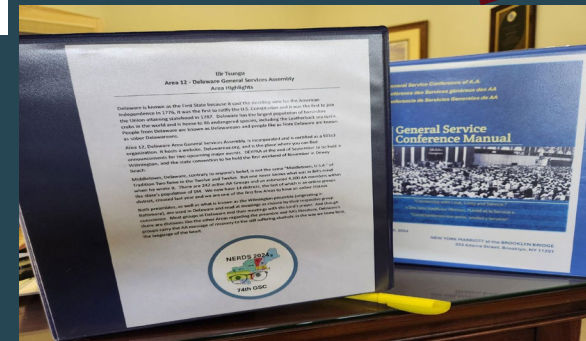

Do you know your General Service Conference lingo?

- **Committee Recommendation:**

Considered to be automatic motions that have been made and seconded. They are discussed and voted on by the Conference. (AASM p.166)

- **Conference Advisory Actions:**

Recommendations of Conference Committees, or floor actions, that have been approved by the whole Conference body with substantial unanimity ($\frac{2}{3}$ vote). Goes to GSB for implementation. (AASM pp. 41-42)

- **Additional Committee**

Consideration: An item was discussed by a Conference Committee, but no action was taken or made by the conference body as a whole. Becomes a suggestion to the corresponding Trustees committee. (AASM p. 85)

- **Floor Action:** An individual decides to make a motion during business which must be seconded by another delegate. (See AASM pp. 41 & 167)

Voting



Substantial Unanimity

- 2/3 of voting members; calculations made for each vote
- Not all members vote on every matter: ranging from 122 – 134 total votes
- Anything less than 2/3 fails
- Minority is the minority unless the majority is the minority (Minority opinion in How The Conference Works – Appendix W, AASM)

Exceptions to Substantial Unanimity & Minority Opinion

- Tabling a motion (no debate, simple majority)

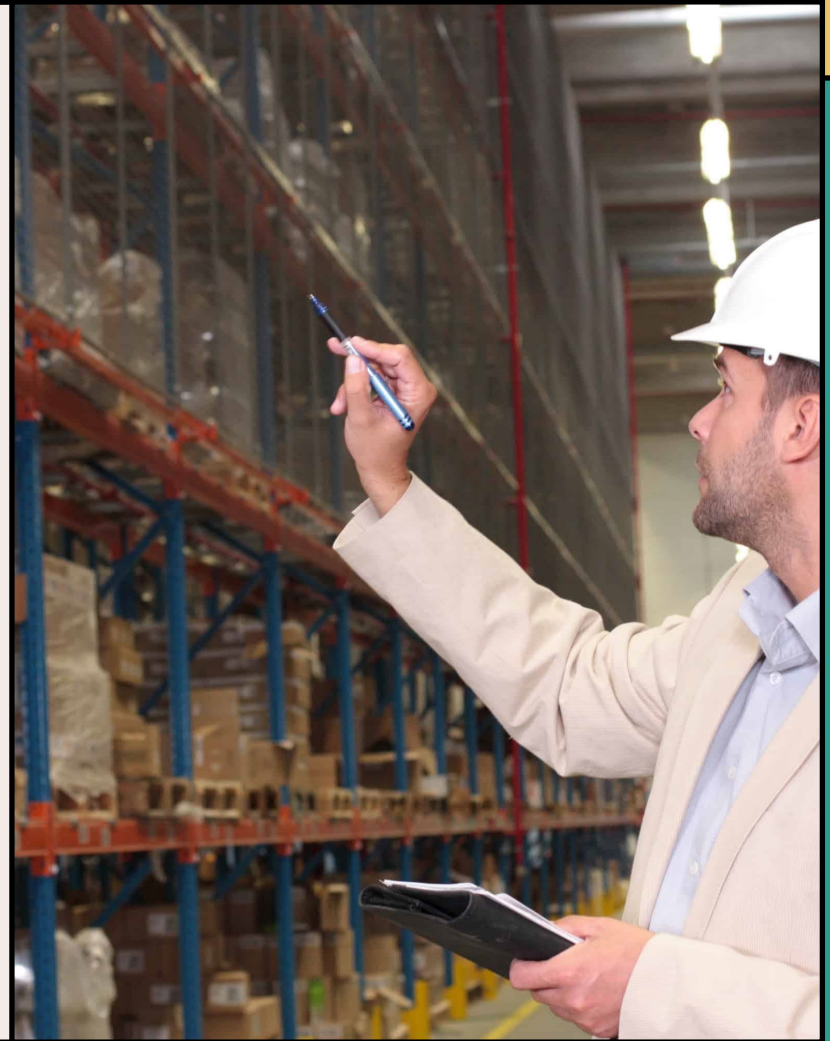


Delaware is known as the First State because it cast the deciding vote for the American Independence in 1776, it was the first to ratify the U.S. Constitution and it was the first to join the Union attaining statehood in 1787. Delaware has the largest population of horseshoe crabs in the world and is home to 86 endangered species, including the Leatherback sea turtle. People from Delaware are known as Delawareans and people like us from Delaware are known as sober Delawareans.

Area Highlights

- Area 12, also known as DAGSA, Delaware Area General Services Assembly, is incorporated and is certified as a 501c3 organization. We hold four to five assemblies annually which includes a pre-conference assembly as well as a delegate report back Assembly, an election assembly during odd years and an inventory assembly during even years. DAGSA hosts a website, Delawareaa.org, to provide information and is the place where you can find announcements for two upcoming major events, DEYPAA at the end of September to be held in Wilmington, and the state convention to be held the first weekend of November in Dewey Beach.
- Middletown, Delaware, contrary to anyone's belief, is not the same "Middletown, U.S.A." of Tradition Two fame in the Twelve and Twelve. But one never knows what was in Bill's mind when he wrote it. Within the state's 1,954 square miles of land there lies 242 active AA Groups – among the registered are five (5) Spanish, twelve (12) virtual, nine (9) women, two (2) LGBTQ, and one (1) YP. There are an estimated 4,300 AA members within the state's population of 1M. We now have 14 districts, the last of which is an online groups district, created last year and we are one of the first few Areas to have an online District. Unfortunately, five Districts are presently inactive though there is a voluntary effort by groups to attend adjoining district meetings.
- Each of Delaware's three counties are also served by their respective intergroups, each having website with a meeting search mechanism for both in-person and online meetings.
- Both preambles are used in Delaware and read at meetings as chosen by their respective group conscience. Many, if not most, Groups in Delaware end their meetings with the Lord's prayer. And though there are divisions like the other areas regarding the preamble and AA's literature, Delaware's groups carry the AA message of recovery to the still suffering alcoholic in the way we know best, the language of the heart.

General Service Board Inventory Advisory Actions 2023

1

To reestablish trust between the General Service Conference, the GSB and the Fellowship of AA, the GSB undertake an inventory prior to the 74th GSC. A 73rd GSC working group to aid in formulating inventory questions.

2

The Trustees' Finance and Budgetary Committee to report quarterly the fiscal performance of the AAWS, GSB and GV Boards throughout the year to the members of the GSC for transparency and reporting to the A.A. Fellowship.

3

The General Service Conference meet outside of the annual meeting for general sharing sessions at least two times per year utilizing virtual meeting technology. The GSB Chair and Delegate Chair will set the date and time and determine topics.

General Service Board Inventory Process

A

Board utilized a facilitator to help conduct inventory sessions.

The three Boards split into five groups, discussed questions and provided thoughts and some solutions.

Twenty- three questions which were divided into the five groups

B

Held Board huddles at Board weekends focused on alignment of the Traditions and Concepts they use to guide their actions.

Policy ad hoc Committee of the GSB. The committee reviewed policies to ensure that they are in alignment with Traditions and Concepts, while meeting the legal requirements for nonprofit organizations in the State of New York.

C

Engaging with the Fellowship wherever and whenever possible, in person or on virtual platforms. This includes forums and other regional events, Area events, District events, and Group events. GSB also engaged in phone calls, email and text exchanges with individuals throughout the Fellowship.

GSB Inventory – Some Responses

- Board supports its members during controversy; some were pressured by those outside the conference; Board unable to defend itself.
- Budgets reflect services and influenced by Conference actions.
- Process for bringing issues forward insufficient; “toxicity” wasn’t evident to everyone at the time; previous efforts to address matters in 2022; issues such as not adhering to bylaws in the forming of committees, not adhering to Concept III when special meetings were held with only a portion of the board and no reporting was provided, and disregard for minority voice are not matters of interpersonal relationships.
- Respect and trust each other.
- Develop a new code of conduct; need a better method of raising concerns.
- “See something, say something.”
- Draw new policies from Concepts and Traditions.
- All communications to reflect group conscience.
- Lack of formal feedback structures; double headed management; authoritarian leadership; unenforced code of conduct; more than one trustee harmful (bullying, marginalizing) silently accepted by board.
- Selection process does not identify deficiencies.
- Workload, workload, workload.

General Service Board Inventory - Top Three Solutions

I

Board development including board huddles, training, orientation, strategic planning away from board weekends

II

Develop cross functional group of conference members to determine communication needs and establish a plan (cadence, rules, timing).

III

Board zero tolerance for misconduct. Address it early. Some situations are serious and require immediate action.

General Service Board Inventory Conclusion

Following the resignation of the Board Chair, the communication from the General Service Board to the Fellowship was ineffective. This was made worse because we failed to anticipate the nature and volume of communications from those not on the General Service Board. Together this caused harm to our staff members, Non-Trustee Directors, and Delegates.

On behalf of the General Service Board, I offer my sincerest apologies for the damage our poor communication has caused. The General Service Board is committed to changing how we communicate, but we're going to need the help of General Service Conference for this to be effective.

PAI 80 - Suspend the search and election of a new General Service Board Chair until the Board's inventory is completed and amends made. Further, that the inventory be shared with all Conference Delegates and approved by the General Service Conference and that the Board solicit recommendations for the amends from the Conference Delegates.

- Inventory shared with everyone – copy is available upon request.
- Board requesting help from conference to create a cross functional group to identify improvements in communication and reporting with no details provided yet.
- No amends made to chair for unprecedented acts; no responsibility taken regarding manner of “resignation.”

Concept V Appeal

- Citing the Board's code of conduct requiring openness and transparency among board members and the Board's bylaws, I posited that
 - There was no vote to request a resignation or to remove the chair
 - The resignation was imperfect
 - There was no due process - no transparency or openness about issues that took place which would have been compelled had there been a more formal removal process
 - Therefore, there was no genuine chair vacancy; that the selection of a new chair was premature
- Prior discussions with three past trustees, one current Trustee & a past delegate of the Conference Trustees Committee
- Provided for a solution to move forward through the application of the Steps which was not undertaken by the Board
- Appeal passed on to new chair per discussion with Interim Chair

Trustee Committee Recommendations

I rose in disapproval of the slate of Trustees and Officers for the reasons cited in my Concept V appeal, stating:

- A. With due respect to the interim and new chairs, and other trustees, I believe a vote for the slate is a vote condoning the board's conduct on January 29, 2023 regarding the chair's resignation;
- B. I cannot in good conscience, and for the good of AA approve the slate because:
 - 1. The board's inventory resulted in only an amend for its post incident communications and it is not willing to acknowledge any error on its part in the incident;
 - 2. When asked about an amend to the chair, the board said it would invite more controversy which reveals internal disagreement and inability to practice certain spiritual principles;
 - 3. When there is a need for an amend, God will provide for the right avenue when earnestly sought;
 - 4. All parties involved have a role that needs to be cleaned up;
 - 5. It is in the interest of AA as a whole that the board show leadership in the practice of the spiritual principle of amends so it cleans its side of the street - that is what we are taught in AA;
 - 6. The board is required by Tradition, Charter and bylaws to follow the spiritual principles of the Twelve Steps.
- C. Therefore, I beg the conscience of the Conference, by vote, to compel the Board to make an amend to the chair and trust God so that history will laud the board's courage and power to forgive.

What Happened Next...

Another delegate from NER moved to amend - trustees be voted on individually.

Chair rejected to address disapproval

Delegate from West Central moved to split motion re individual vote.

Motion rejected by chair

Chair explained process - disapproval returns slate to Nominating committee for decision or reorganization.

Board selects its successors

Delegate from West Central then moved to reject chair's decision.

Seconded – discussion followed

NER Delegate cites bylaws referencing voting for trustees individually

Chair: For vacancies only

SER delegate cites bylaws referencing Conference's power to disapprove new trustees.

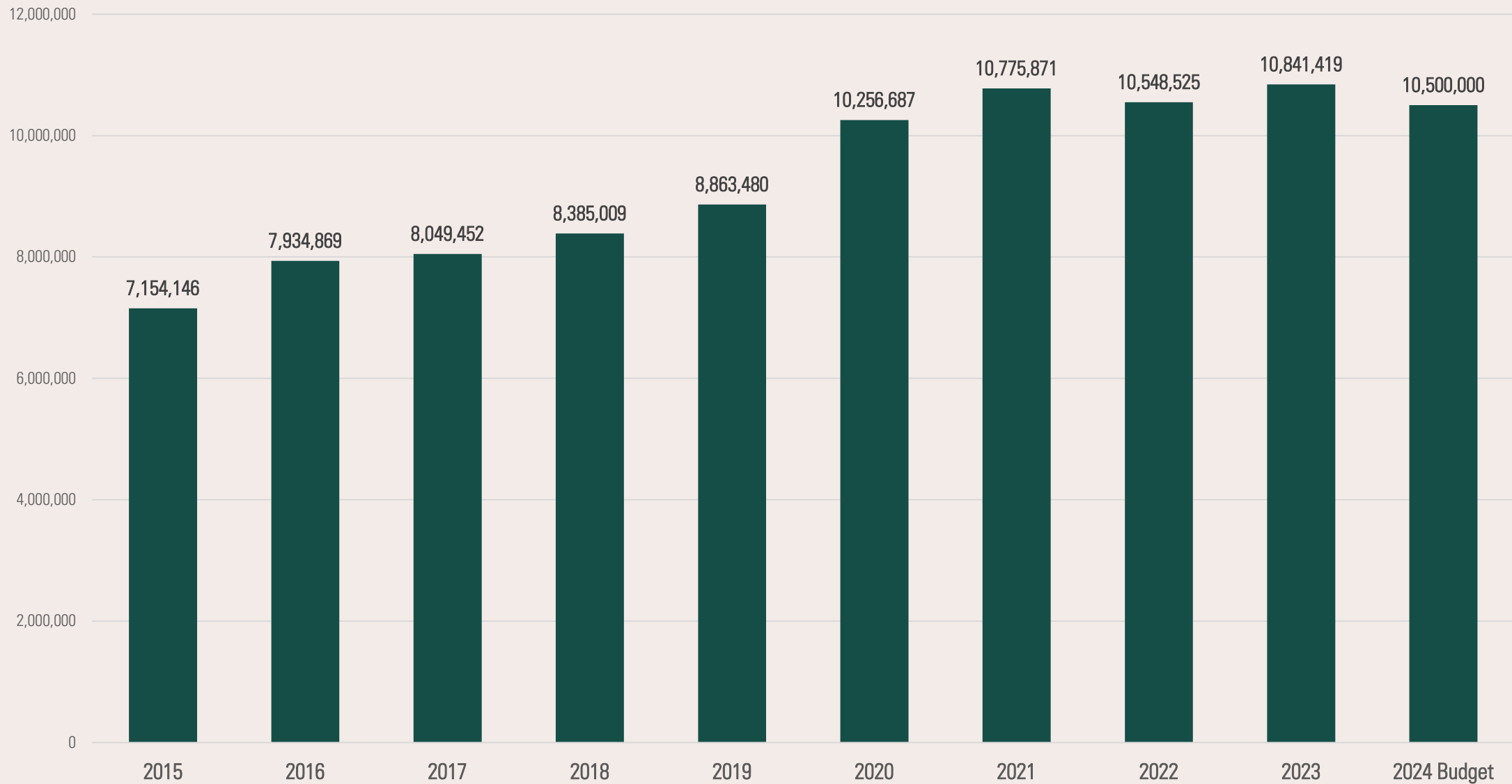

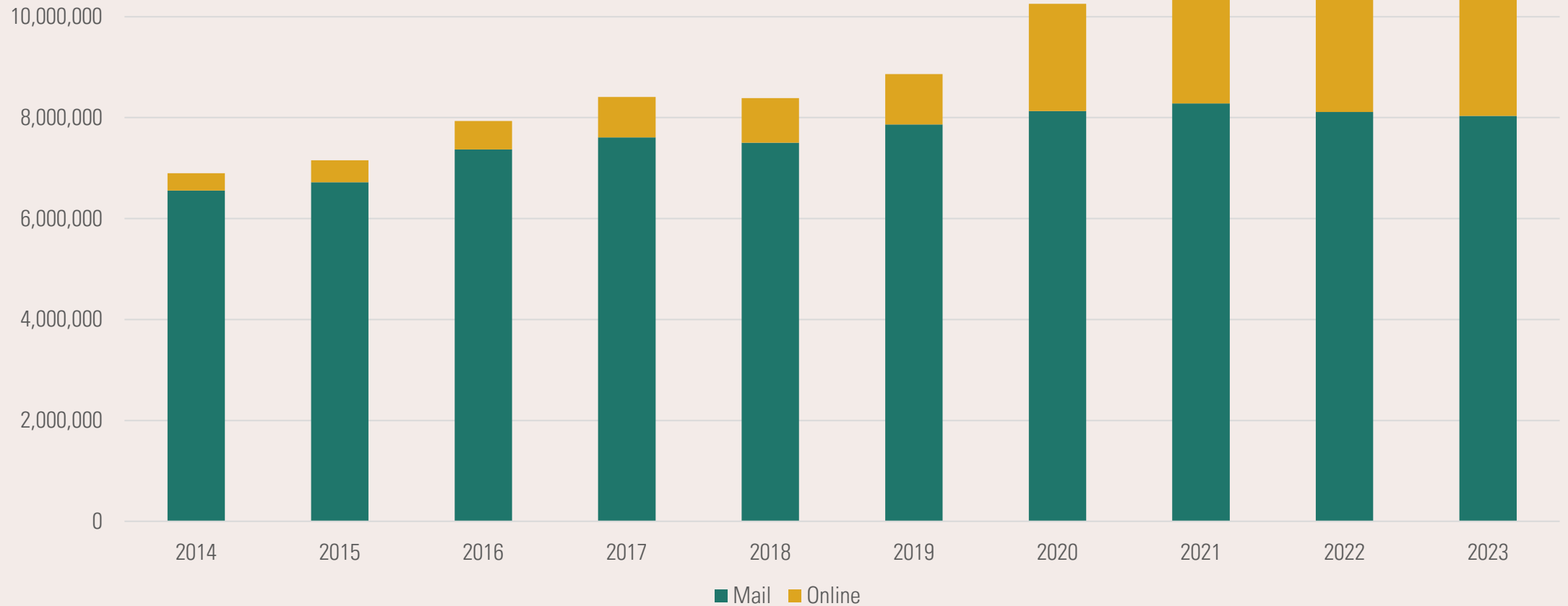
Financial Audit

- Cause for delay in Reporting EOY financials to Area Delegates: new auditors and numerous consultations
- “Clean audit”
- GSO must report Value of PSA’s as income and expense
 - Bookkeeping matter, not IRS requirement
- Some bookkeeping errors:
 - 100 2024 contributions counted in 2023 (weekend contributions)
 - Post retirement accounting errors
 - GV accounts receivables not updated regularly
 - Payroll changes not properly documented (internal controls)
 - No intercompany agreement for transactions (internal controls)

7th Tradition Self-Support 2015-2023

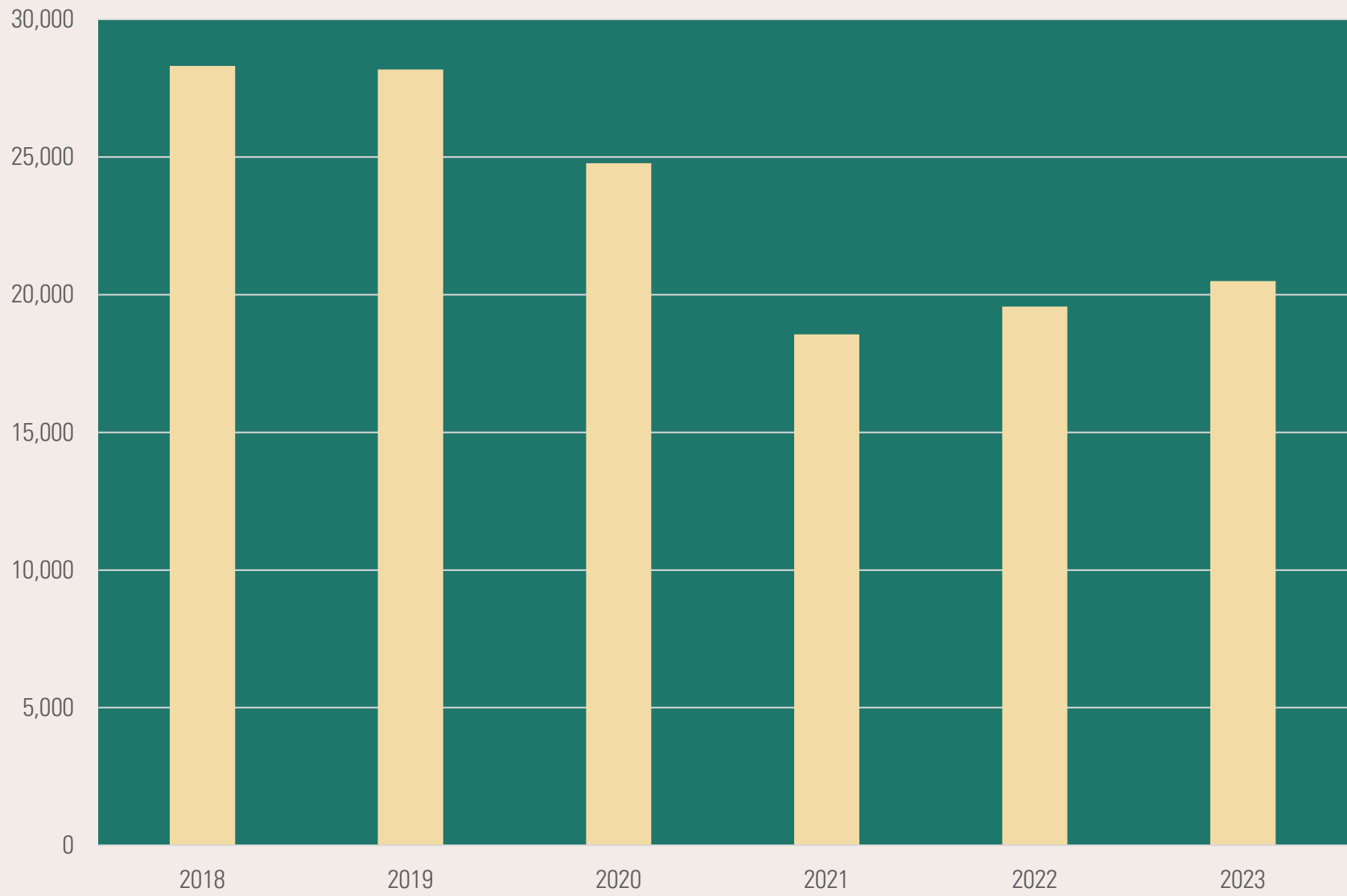


Growth of Online Contributions 2014-2023

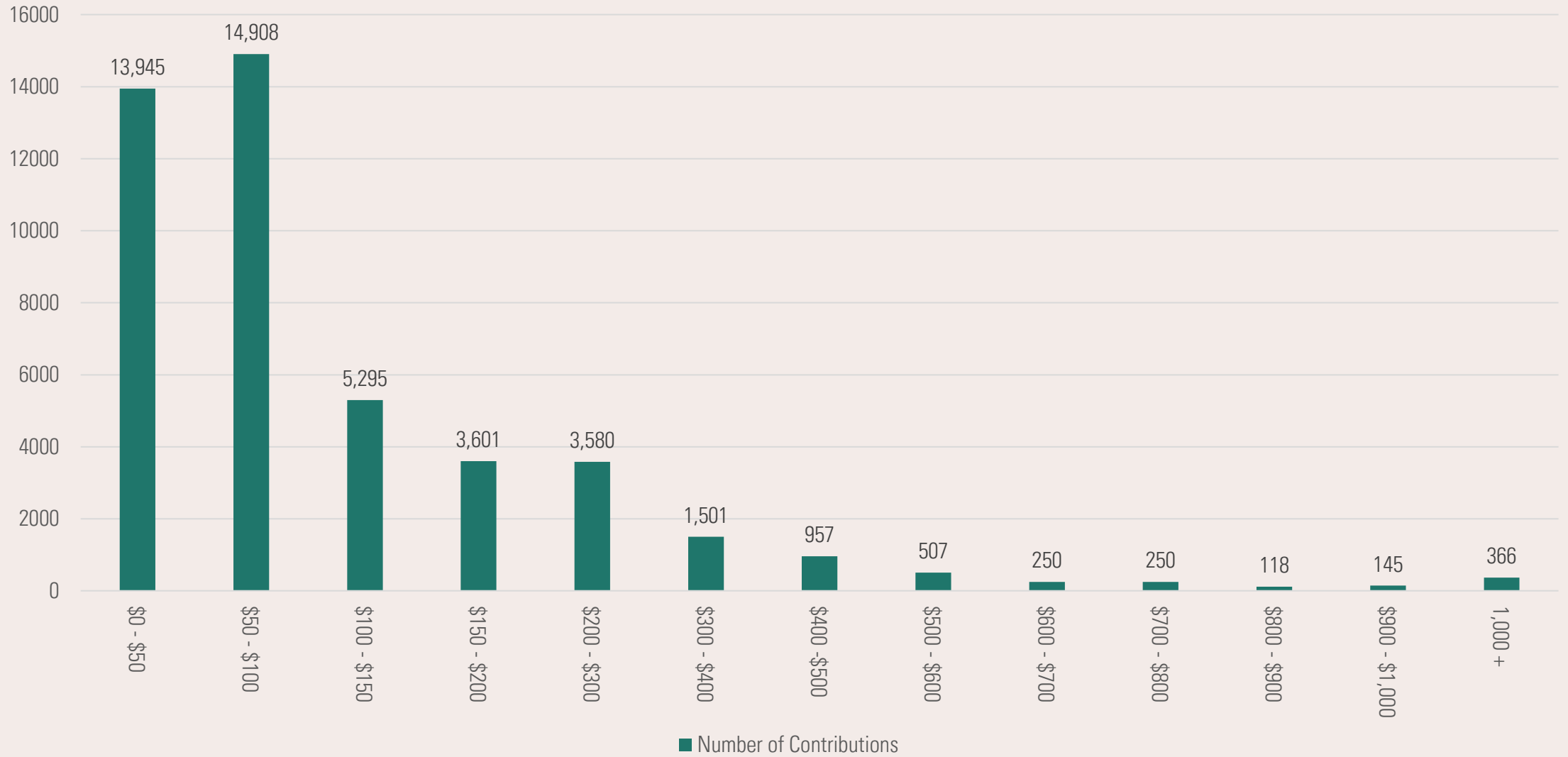


A mail contribution costs \$5.60 to process. An online contribution costs \$2.93 to process, a \$2.67 savings.

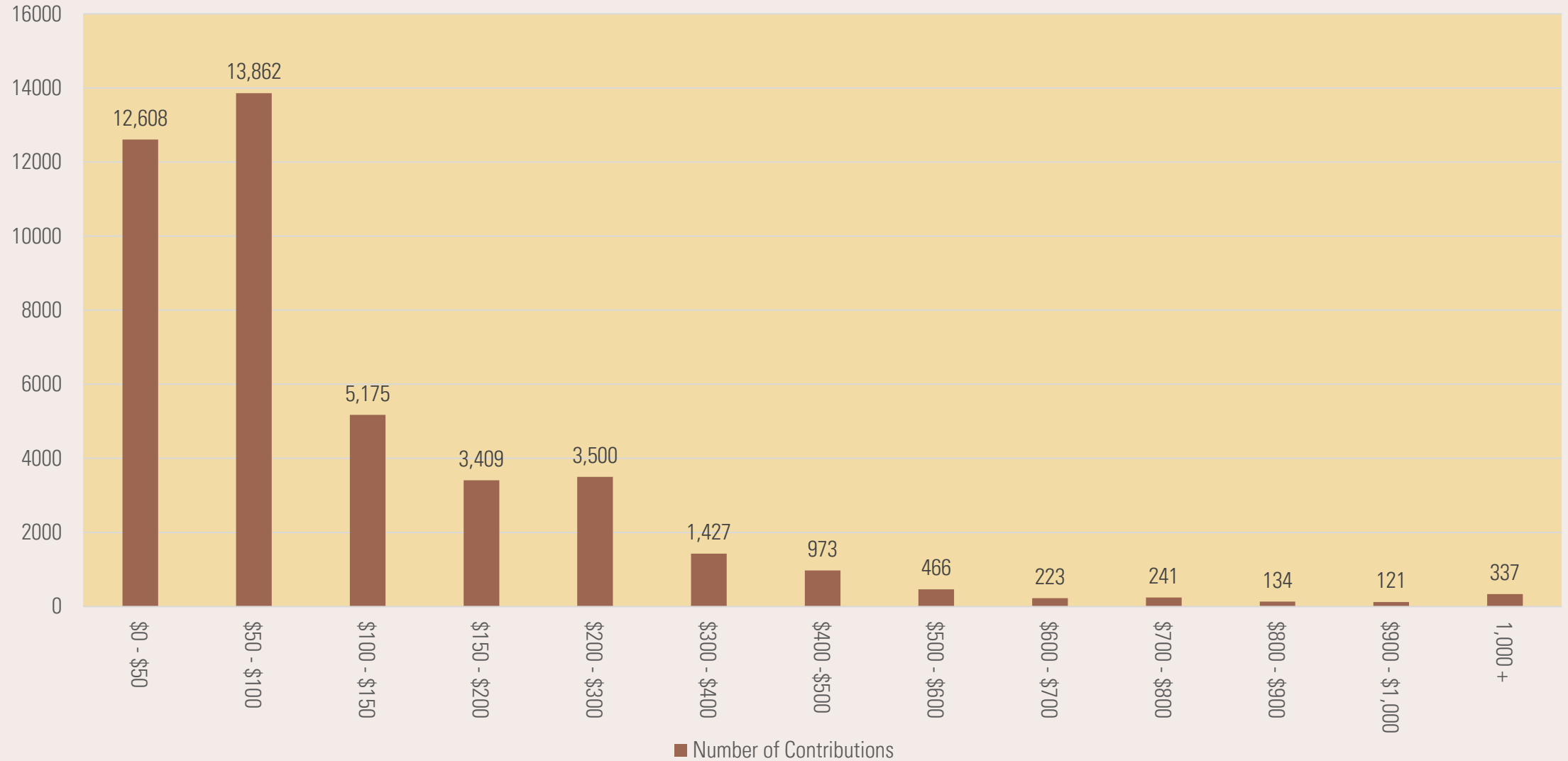
Number of Groups Contributing 2018-2023



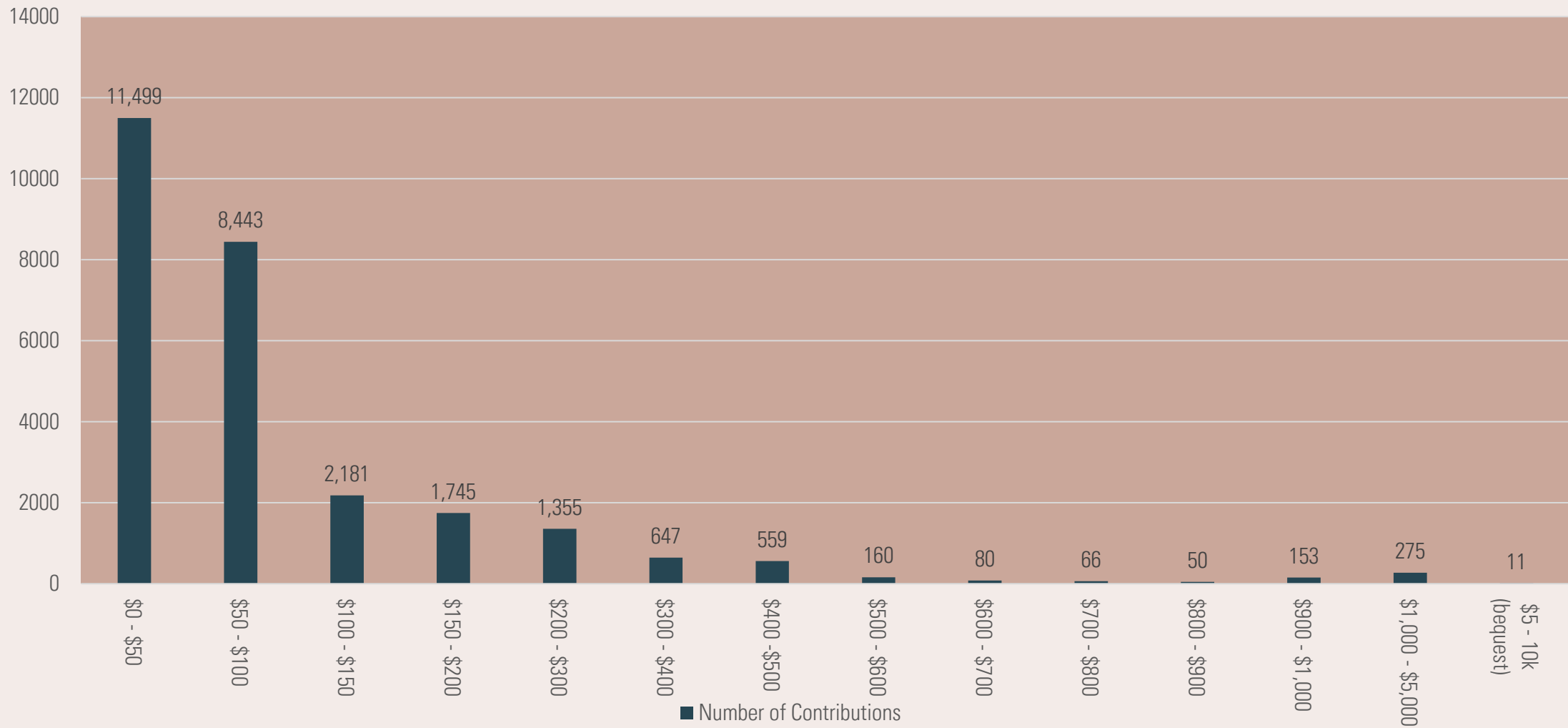
Group Contributions by Dollar Value - 2022



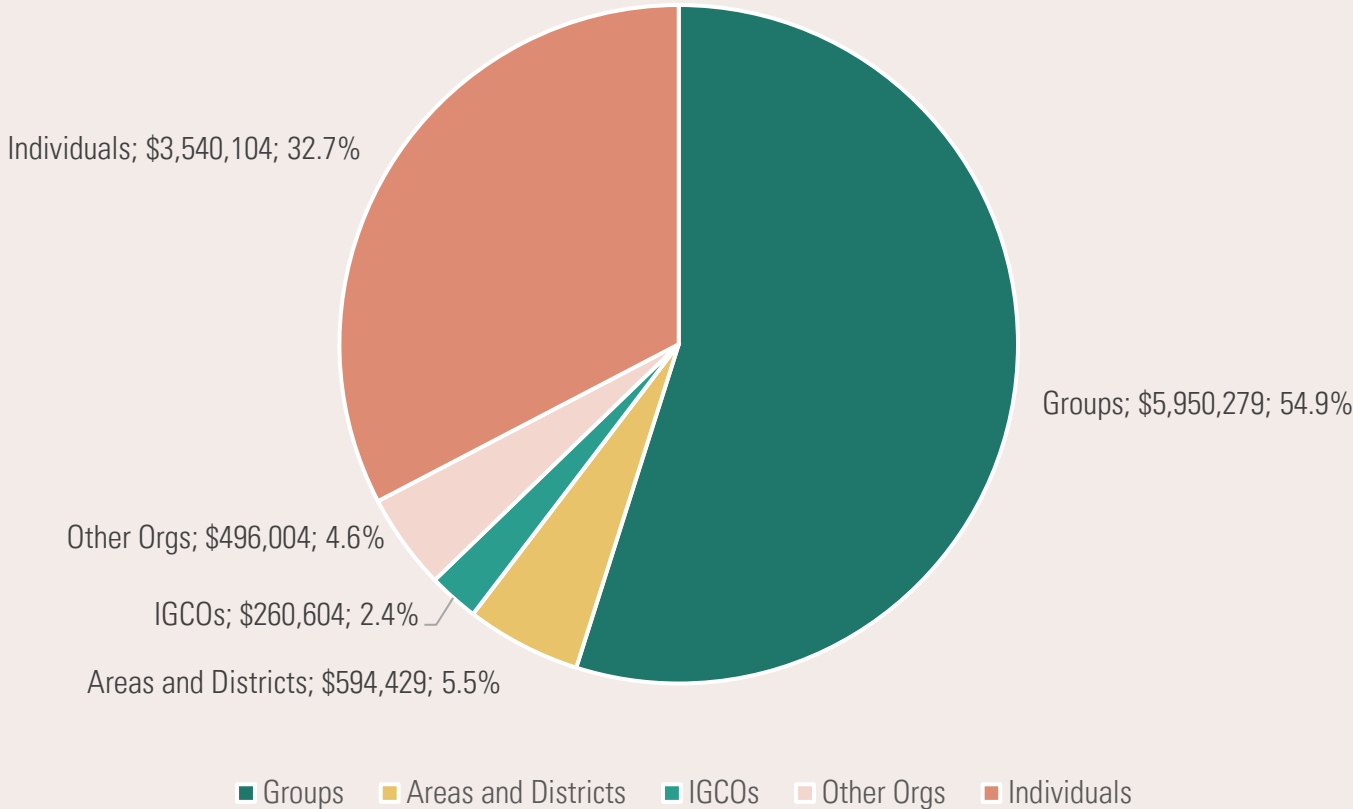
Group Contributions by Dollar Value - 2023

2023 Grapevine Financial Highlights

- App launch – September 1, 2023

- 2023 Grapevine results were a gross margin on subscriptions of \$601,088 and a gross margin of \$562,746 on other published items. Operating expenses of \$2,059,058 resulted in an operating loss of \$888,465 compared to a loss of \$404,940 in 2022.
- General Fund support of La Viña service activity was \$753,376 in 2023, compared to \$636,604 in 2022.
- La Viña magazine circulation decreased by 3.0% in 2023 compared to a 4.3% increase in 2022.

Let's Talk About Depreciation

- Remember the November 2023 Gratitude Letter From GSO General Manager?
- It went out directly to the World, not just US/Canada
- It indicated that AA was going to experience a shortfall:
 - “Because of the significant decline in literature sales and revenue and the large cash outlay needed to continue printing and distributing our literature, we have also experienced a very tight cash position. Our reforecast budget for this year estimates a loss of \$997,000, after depreciation and the GSB support of La Viña”
- Depreciation, a non-cash expense, was re-forecasted (midyear) at \$1.2M and ended as \$1.06M in 2023; literature sales increased before April 2023 price increase
- Numerous questions on this arose at 2024 NERAASA

Let's talk about Depreciation

What's On Your Mind Session

The sentiment from Area 12 on this matter is in regards to the Gratitude letter and its follow-up. I ask for caution [from the Board & GSO General Manager] and I do so with gratitude to service rendered at GSO.

1. Restraint from including depreciation unless there is a planned expense directly related to depreciated capital that requires replacement
2. Restraint from language that can be perceived as instructive. i.e. in the January letter advising groups to make regular contributions – Alcoholics don't like to be told what to do especially in light of Tradition Four

While, understandably, there was an immediate benefit [to GSB], alcoholics don't have a short memory and the unintended consequences may prove damaging financially and spiritually in the long term.

Founders Writings – Area 12 Report To The Conference

Our Districts considered both sets of questions from Trustees and Conference committees. Most felt the founders would embrace change but a few noted that the decision lies with the Fellowship; that the founders respected the wider conscience. Most felt the BB/12&12 are effective with newcomers because they help in getting people together (sponsorship, BB studies, BB Meetings, 12x12 meetings, etc.) yet, at the same time, they were highly sensitive to those in need for plainer text which they encouraged. The BB is to be studied rather than read. Others mentioned that AA recovery does not depend solely on the BB.

Changes to language in the BB and founders writings brought out strong feelings on both sides. However, most understood reasons to update language and many agreed footnotes would have a positive impact. Preserving the language through the tools we have today was dominant; PLBB, new texts, numerous publications are helpful ancillary texts. These can address the needs of the changing culture in our society.

Founders Writings – Area 12 Report To The Conference

Complete rewrites and replacements were in a small minority. As the desire increases for change, the predominant thought was to have a slow process such as multi-year reviews of decisions made, careful consideration by wider inclusivity of the Fellowship, and the use of super-majority. Many in the fellowship on both sides felt a need to review actual changes before final actions are taken. The issue of codifying the preservation of this literature in the same manner the Steps and Traditions are protected came up.

Other interesting comments were made such as AA was never meant to be instructive; that the sharing of experience, strength and hope was the primary method for introduction and sustenance of recovery. And, as you may well guess, the discussion of finances were not ignored by some of our Districts. As for the changes to the 12 & 12, footnotes were the way to go. However, those responses were presented by both sides of the fence as the feelings were pretty much equal about the change.

Founders Writings - Background



Trustee Literature Chair remarked that the Area sharing on Founder's writing to be considered by Finance Committee for Item C (EDW) – Review shared experience



Finance committee discussed the item focusing on whether there should be a policy. All eight members agreed that a policy would not be prudent – ambiguity, formulation & trust.



Committee voted 7-1 to take no action - Existing process sufficient. I voted against. 1 Other delegate moved to reconsider after minority opinion – no second.

Founders Writings – Counter-point

I don't see why the Big Book and the 12x12 cannot be preserved in the Conference Charter.

It will not be a detriment now or to posterity 20 or 50 years hence. It wisely protects the historical text from edition to edition, frees it from the ever-expanding footnote dilemma for time immemorial while, at the same time, does not interfere with the Fellowship's desire to publish additional ancillary texts, of its choosing, to serve our ever-evolving society and culture as we march on through history.

Founders Writings – Follow-ons

Committee Considerations

The committee reviewed the progress report reflecting shared experience from the Fellowship on possible future changes to literature written by A.A.'s founders and took no action. After thorough consideration and mindful reflection of the comments received from Founders' Writings sharing sessions, as well as the valuable input received from the Fellowship via Area Delegates, the committee agreed that current Conference procedures provide a process wherein future proposals for changes can be considered by the group conscience of each Conference, negating the need for a mandated policy.

What Happened Next

- One delegate expressed feelings about Trustee Literature Committee rejecting 73rd Conference Finance Committee's proposed question
- I prepared a Floor Action – Submitted next day after deliberation and consultation & PLBB vote

Founders Writings – Floor Action

Whenever any changes are brought to the Conference floor to the Founders' writings, considered by this motion to be:

1. The book *Alcoholics Anonymous* — specifically, the first 164 pages, the chapter “The Doctor’s Opinion,” Forewords to the first and second editions, the Appendices on Spiritual Awakening and the Traditions, and Dr. Bob’s Nightmare
2. The book *Twelve Steps and Twelve Traditions*

The Conference must achieve a supermajority of 75% for the General Service Board to act upon it. However, the General Service Board shall not immediately act upon the Conference’s directions, and instead, shall request all Area Delegates to conduct further discussions in their respective Areas. Area delegates’ report backs will be conducted the second following General Service Conference at which the Conference may amend or change the previously approved change to the Founders’ writings described above. For final action by the General Service Board, the Conference must achieve substantial unanimity.

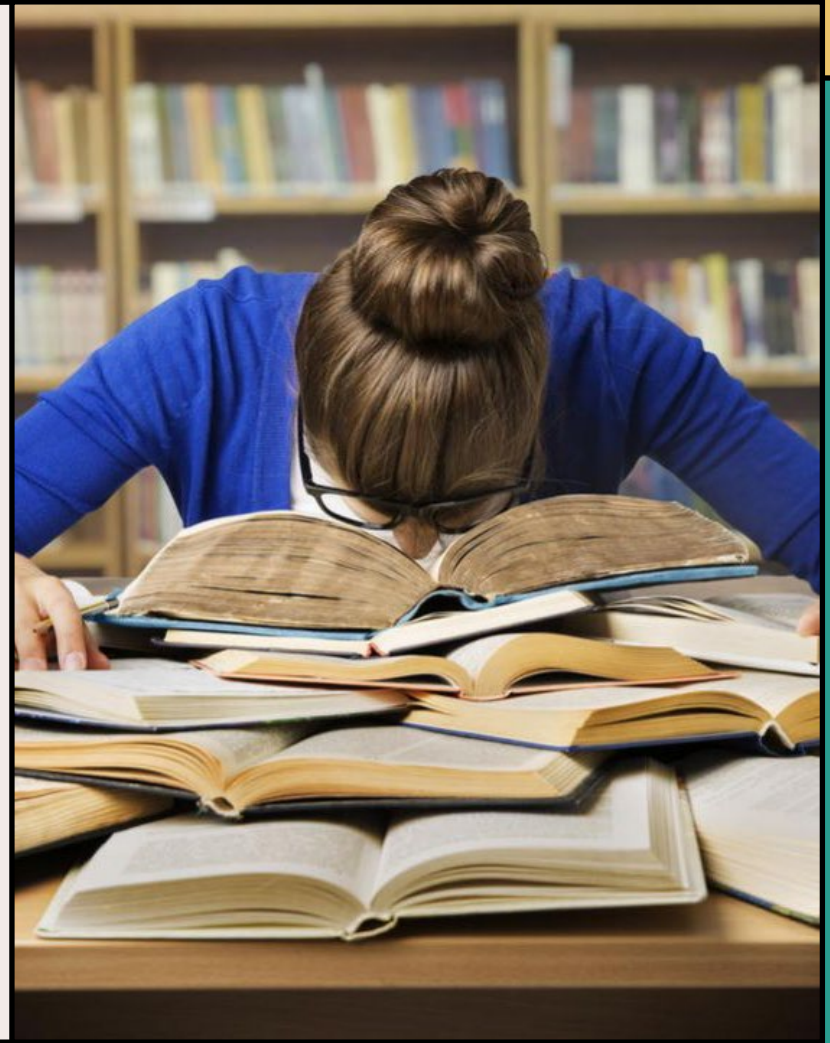

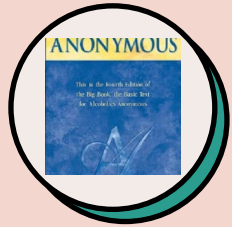

“On balance, the business case to move does not appear supportable at this time, given upfront costs as high as \$7.1 million, and likely very high attrition of staff (>80%), in turn impacting the ability to support GSO’s service mission to Members.”

- ROI of moving would be between 3 and 9 years depending on the city
- Atlanta seemed like the best choice, based on a variety of metrics.
- Used outside vendor to help determine the feasibility of moving the office
- Looked at moving in the city, nearby, or to a different city
 - Outside cities were finalized to be Atlanta, Indianapolis, and Philadelphia
 - Started with 116 different metro areas across the country
- We will not be renewing the lease on the 8th floor for savings of about 1.4 million over 10 years.
- This will require renovations to current floor to account for more offices and staff, which will cost about 1.4 million.

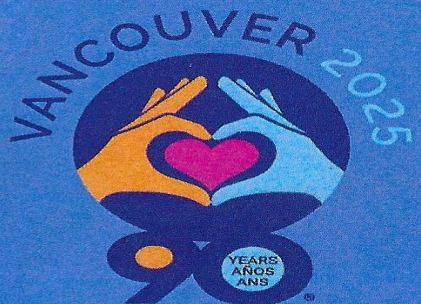

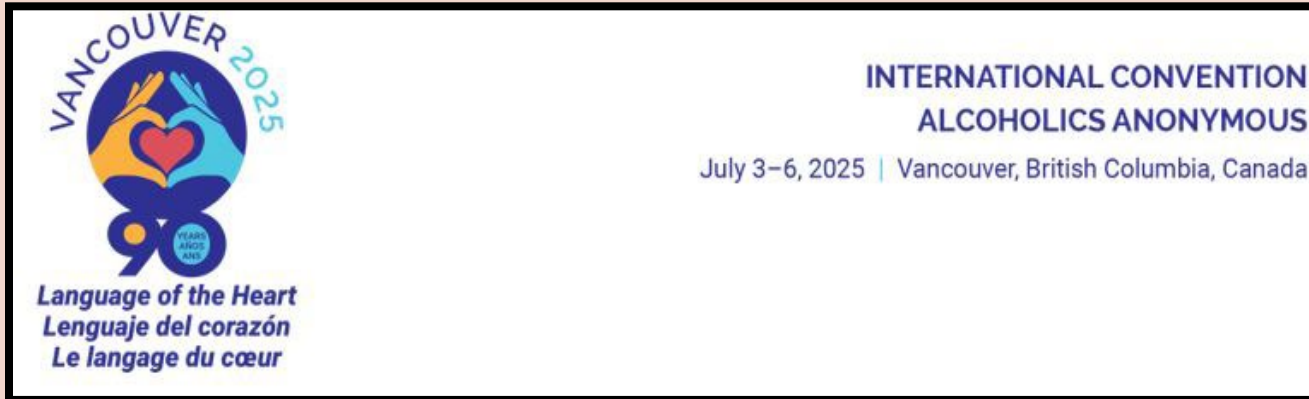

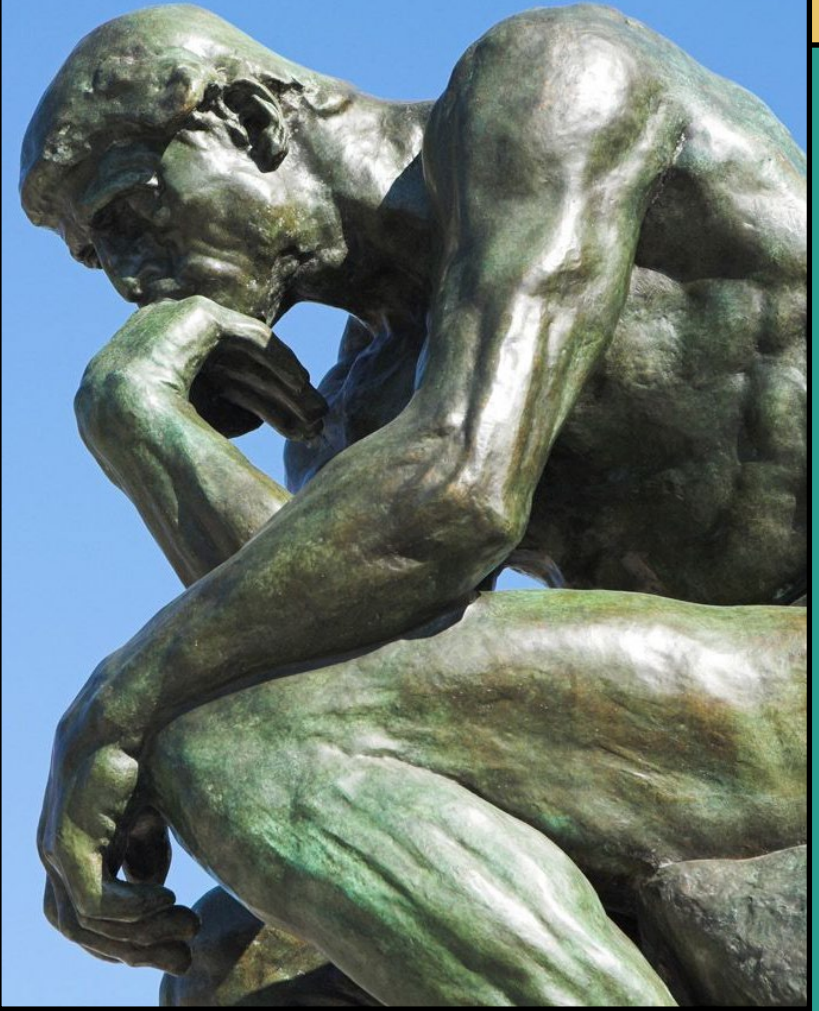

Agenda Committee

The committee discussed the value of Workshops during the Conference week and noted that local committees conduct workshops based on these topics and provide opportunities to inform delegates with a broad range of experiences.

The committee discussed the number of videoconference meetings that occur within service areas, regions, and for Conference Members. The committee felt that some local events share misinformation, or inconsistent materials, which is troubling. The committee discussed ways that could help clarify and support accurate information and felt that the three Board chairpersons could explore aligning their efforts to share information within the Fellowship.

CPC & Corrections Committees

The CPC committee reviewed a progress report on the development of an outward facing pamphlet for mental health professionals and noted the continued work moving forward toward the production of the pamphlet. The committee requested that a progress report or draft pamphlet be brought back to the 2025 Conference Committee on Cooperation with the Professional Community.

The Corrections committee requested that the staff coordinator on the corrections desk gather shared experience on how local corrections committees encourage and engage members in corrections service. The collected shared experience would be available upon request from the corrections desk

Grapevine Committee

The committee requested that the Grapevine Board develop a plan for a more effective La Viña subscription procedure, fulfillment process and customer service experience and that a progress report be brought back to the 2025 Conference Committee on Grapevine and La Viña.

The committee requested that the Grapevine Board develop a Grapevine and La Viña financial reporting system that is clearer and easier to understand for the Fellowship.

The committee felt they needed feedback from the Fellowship and requested that the Grapevine Board conduct a survey to the membership to identify relevance, usefulness and financial viability of products and services provided by the AA Grapevine, such as Podcast, Instagram and YouTube, with a report to be brought back to the 2026 Conference Committee on Grapevine and La Viña.

ICRF Committee

The committee requested that the trustees' International Convention and Regional Forums Committee explore ideas to develop a new declaration to be adopted at the 2030 International Convention. The concept is to review the history of The Responsibility Statement or the "I Am Responsible" Declaration that was introduced at the 1965 International Convention in Toronto. In addition, the history of the "Unity" declaration that was introduced at A.A.'s 35th Anniversary International Convention held in Miami Beach, Florida in July 1970. The committee looks forward to a progress report being brought back to the 2025 Conference Committee on International Convention and Regional Forums.

Literature Committee

The committee reviewed a progress report on revisions to the pamphlet, “The Twelve Steps Illustrated.” The committee requested that a new draft, partial draft, or progress report be brought back to the 2025 Conference Committee on Literature.

The committee reviewed a progress report on revisions to the pamphlet “A.A. for the Native North American.” The committee noted that the introduction section has been drafted and that outreach efforts have been efficient, effective, and resulted in an increased number of story submissions. The committee requested that a draft or progress report be brought back to the 2025 Conference Committee on Literature.

The committee reviewed a progress report on the video animation of the pamphlet “The Twelve Concepts Illustrated.” The committee requested that the project proceed with Phase II Option I to include translation of narration voiceover and visual text into French and Spanish.

Public Information Committee

The committee recommended the QR codes be added to

- ✓ PSA announcements
- ✓ The Flyer “AA At A Glance
- ✓ The Pamphlet “Speaking at Meetings Outside A.A.”

The committee reviewed the memo from GSO's CFO related to tracking Public Service Announcements, noting that \$48,000 to track PSAs has been accepted as an audit requirement. The committee requested that this expense be allocated to the trustees' Finance and Budgetary Committee budget. The committee suggested that for the tracking of PSAs more cost-effective means of tracking be researched.

The committee discussed the Mesmerize Point Public Service Announcement (PSA) distribution and was pleased to see the ongoing opportunity to reach a large audience at no cost. The committee suggested that the trustees PI Committee renew the annual contract with Mesmerize Point for the 2024-25 year, providing it could be done so at no cost. The committee suggests research to see if it is available in Canada.

Public Information Committee

The committee reviewed and accepted the 2023 Report on the Alcoholics Anonymous World Services, Inc. Meeting Guide app. The committee offered the following suggestions and looks forward to a report to be brought to the 2025 Conference Committee on Public Information:

- Consider a suggestion to add A.A. literature to the Meeting Guide app.
- Consider creating a mechanism for listing online meetings on the Meeting Guide app without tying them to particular locations.
- Consider adding a clarification to the location information on the Meeting Guide app to specify that locations (like churches) do not imply affiliation.

- ❖ (H) Ch. 11 – We found a solution / How AA Has Grown / The Fellowship Today
- ❖ (SB) Dr. Opinion – Craving; an irresistible urge to drink; obsessive thoughts about alcohol that compel the drinker to start drinking and keep drinking
- ❖ (H) Bill's story – Learning about alcoholism at hospital / A Visit From A Friend

Plain Language BB: Report-back

- Page 164 – “Our book is meant to offer you suggestions only...This is the great fact for us...Give yourself to God as you understand God. Admit your faults to God ...May God bless you and keep you until then
- After 5th step directions – not taken out
- Retiring at night & upon awakening – not taken out
- The four horseman – not taken out
- Contempt prior to investigation - now says “(paraphrased from) Herbert Spencer”
- Deep down in every... (Ch 4) - God is already within you – deep down in every person is the simple and powerful idea of God. It may be hidden by personal problems or by worship of other things, but it is still there.
- Step 9 promises – much the same with a definition of serenity in the sidebar; extravagant to outrageous or unlikely
- Step 10 promises – It’s just our new reality
- Bill’s story – “why don’t you create your own idea of who or what God is....That idea changed everything for me.

Literature Committee Recommendation - PLBB

The draft manuscript *Plain Language Big Book: A Tool for Reading Alcoholics Anonymous* be approved with minor editorial changes to include:

- Relocation of the “A.A. Steps Table” to constitute an Appendix (on the Twelve Steps) at the back of the new publication.
- Replace the references to “addiction” and “addicted” with language related to alcoholism.
- Literature Committee met Saturday before Conference from 8am – 6 pm to read, review, discuss, and tweak the draft manuscript
- Every other conference member was given 2 hours with the book (P73’s - Two sessions one last year and again this year)

- Six to 7 hour discussion on floor beginning Thursday evening appx. 7:45 PM to midnight then again in the Friday AM beginning 9 AM
- First order of business was motion to require 75% supermajority; motion had to be un-tabled first – 61Y-69N (2/3 needed) motion fails (I voted in favor)
- Amendments
 - Bill & Bob's stories to be made as side by sides 16Y-112N Motion fails
 - Remove explanations of Steps, Traditions and concepts 32Y-97N Motion fails (I voted in favor) > motion to reconsider 55Y-74N (SM) Motion fails (I voted in favor)
- Motion to recommit 35Y– 95N Motion fails (I voted in favor)
- Motion to call the question on recommendation 99Y-31N Motion passes
- Motion on recommendation 91Y-38N Motion passes (I voted against)
- Minority opinion > motion to reconsider 58Y-71N Motion fails (I voted in favor)
- Silence - people on opposite sides hugging; some crying
- Almost everyone was for the book, even its harshest critics, but many thought it was not ready yet. On the other side, some “frothy emotional appeal”

Pros

- “When Jesus was asked what book to read, he said the one you can read.”
- We can pass it now and fix it later

- Testimony from Hispanic delegates on their experience reading the PLBB

Cons

- Citing Charter, explanation of Steps and Traditions is tantamount to a rewrite
- Will create more PAI’s than you can imagine
- Will cause more division and more groups to withhold contributions
- There is much to be fixed in the book
- Need for the fellowship to read it first

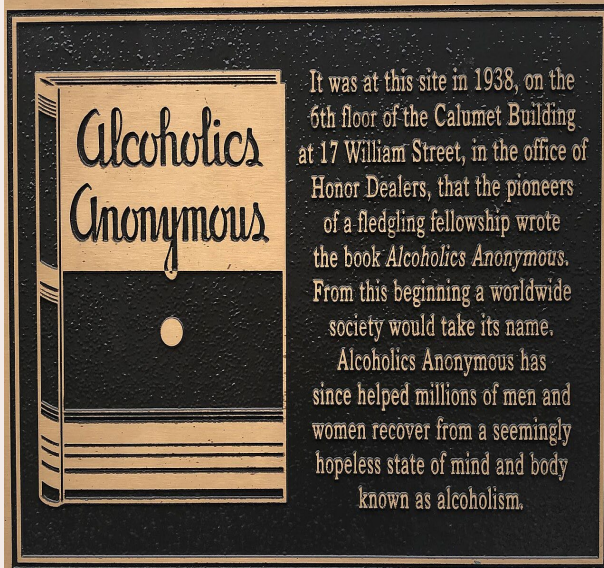
Fifth Edition Big Book

Did You Know?

- ❖ The BB is on the Guinness World Records list of all-time best selling books.
 - ❖ In 2011, Time magazine placed the book on its list of the 100 best and most influential books written in English since 1923, the year in which the magazine was first published.
 - ❖ In 2012, the Library of Congress designated it as one of 88 "Books that Shaped America."
- ❖ Much of the book was written in 1938 at the Calumet Building in Newark, NJ (the site of first 'headquarters' of AA), using the secretarial services provided by Ruth Hock. (See plaque, above.)
 - ❖ President Richard Nixon received the millionth copy of the book. The 25-millionth copy was presented to Jill Brown, the warden of San Quentin State Prison, at the International Convention in Toronto, Ontario to commemorate the first AA prison meeting taking place at San Quentin in 1941. The 30-millionth copy of the book was presented to the American Medical Association in 2010, which declared alcoholism an illness in 1956.

1. A pamphlet for the unhoused person that specifically addresses alcoholism, what A.A. is and is not. (*Decline to consider 90Y – 39N, Passed*)
2. Censure and reorganization PAI's have no submission deadline and be forwarded directly to Conference Committee on Trustees. (40Y – 87N, Failed)
3. A pamphlet on the Asian and Asian-American alcoholic in A.A. be developed. (99Y – 27N, Passed AA – discussed previously)
4. All memorandums between Conference Committee and Trustees Committees or Boards be made available to all members of the Conference. (*Decline to consider 119Y – 7N, Passed*)
5. La Viña continue to be published by the AA Grapevine and supported by the General Service Board utilizing AA Grapevine resources to achieve efficient production and distribution. (Recommitted by motion – lack of time to consider)
6. The Grapevine Board develop a plan for a more effective La Viña subscription procedure, fulfillment process and customer service experience. (Recommitted by motion – lack of time to consider)

7. All non-offensive PAs submitted for consideration of the 72nd, 73rd and 74th General Service Conferences regarding the change made to the A.A. Preamble by the 71st General Service Conference be grouped as one item, and forwarded to the appropriate 75th General Service Conference committee with the following suggestion: given the importance and interest of this issue, consider forwarding the item to the general service areas for wider discussion, looking toward a fair and reasonable solution to the division within the Fellowship by the use of different copyrighted Preambles. (Recommitted by motion – lack of time to consider)
8. The additional feedback from the Conference Committee on Literature identified in their memo to the publishing Department on sticking points for the PLBB. (Discussed at Slide 96. Recommitted by motion – lack of time to consider)
9. Whenever any changes are brought to the Conference floor to the Founders' writings...(Previously discussed at Slide 58. Recommitted by motion – lack of time to consider)

Floor Actions

10. The AA Grapevine Board develop a 5-year financial plan for the Grapevine with the goal to reduce shortfalls and increase revenue to be brought back to 2025 Conference Committee on Grapevine and La Viña. (Recommitted by motion – lack of time to consider)
11. Reaffirm 1975 AA that delegates place more emphasis on group support to the GSB due to inflation. (Recommitted by motion – lack of time to consider)

Floor Actions

12. Delegates who require translation be provided with all documents, materials, reports, communications, etc., in their native language, with all necessary information to be able to fulfill their role as trusted servants, bearing in mind the traditional Right of Participation. (Recommitted by motion – lack of time to consider)
13. In the flyer “A.A. At a Glance” — in the last paragraph on page one under the heading “Who can attend A.A. meetings?” that the last sentence “‘Closed’ discussion meetings are for alcoholics only” be changed to: “Attendance at a ‘closed’ meeting is limited to A.A. members and persons who have a desire to stop drinking.” (Recommitted by motion – lack of time to consider)
14. The explanations of the Steps, Traditions, and Concepts be removed from the Plain Language Big Book. (Discussed at Slide 96. Recommitted by motion – lack of time to consider)
15. Retitle the Plain Language Big Book to: “The Plain Language Guide to A.A.’s 12 Steps of Recovery.” (Discussed at Slide 96. Recommitted by motion – lack of time to consider)

I think that we have developed almost a fetish that here is some terrific infallibility in the group conscience and I would like to modify it to this extent; that when the group conscience is thoroughly informed, and when experience backs a decision or conclusion it has reached, and when it isn't too mad or too fearful it can be (and almost always) supremely wise as to the best interest of Alcoholics Anonymous.

...and there is a little addendum there

that gets overlooked: that's called the *trusted servant*.

Now we're getting into the area of our affairs...of defining what should be the trusted servant relation to the group conscience. This is not so easy a definition, for this is a definition of *leadership* under God, under the ultimate authority of the group conscience, which can be wrong sometimes. And it has to take into consideration the extreme fallibility of the so called trusted servants...

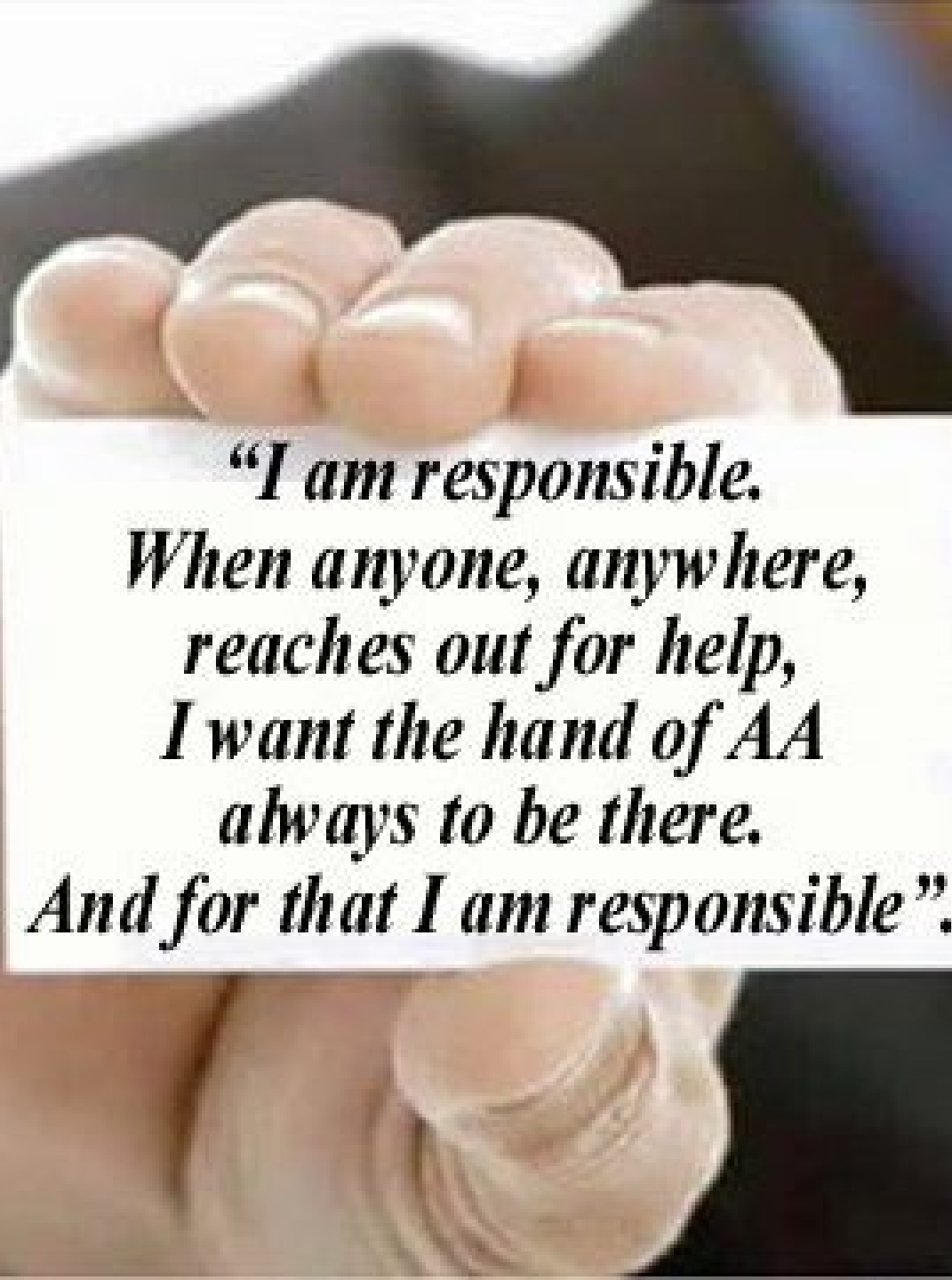
